Members and associates may, subject to approval, hire the reception rooms for meetings and social functions. The charges for these are:

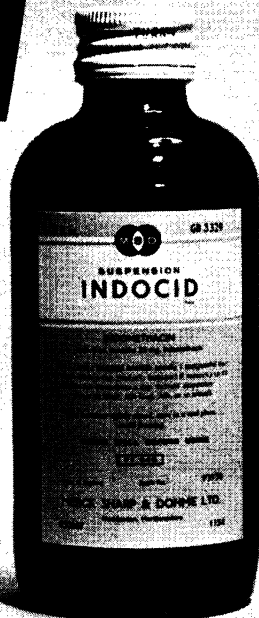
Long room (will seat 100)	25 guineas for each occasion

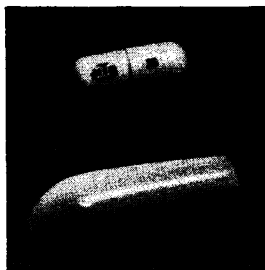
