MEDICAL NEWS

UNIVERSITY OF NOTTINGHAM AND THE ROYAL COLLEGE OF GENERAL PRACTITIONERS

The Sir Harry Jephcott Visiting Professorship in General Practice for 1974–75 has been awarded to the University of Nottingham Medical School by the Royal College of General Practitioners and Dr John Horder O.B.E., M.A., F.R.C.P., F.R.C.G.P., has been appointed.

Dr Horder will spend about 12 weeks spread throughout the year in the medical school, teaching in the programme of basic medical sciences of the Department of Community Health, in various ways in the clinical course, and in postgraduate teaching both in the medical school and in the Nottingham and Derby vocational training scheme for general practice.

The Professorship is supported by the Research Foundation Board of the Royal College of General Practitioners and the appointment is made by a joint committee from the Royal College of General Practitioners and the medical school.

CHAIR OF GENERAL PRACTICE AT GLASGOW

Obituary

ROBERT JAMES MINNITT M.D., M.Sc., F.F.A.R.C.S., F.R.C.O.G., F.R.C.G.P., D.A.

The College and in particular the Merseyside and North Wales Faculty has lost a distinguished practitioner in the death of Dr R. J. Minnitt.

Dr Minnitt was born on 25 October 1889. He graduated M.B., Ch.B. from Liverpool Medical School in 1915. In 1919 he entered general practice. At the same time he held honorary appointments in anaesthesia in Liverpool Royal Infirmary, David Lewis Northern Hospital, Liverpool Maternity Hospital and the Royal Liverpool Children's Hospital among others.

He was responsible for the development of a machine by which nitrous oxide and air could be administered by mothers during childbirth. This was a major advance of enormous importance in the relief of pain in childbirth. He also had the further task of persuading the Central Midwives Board in 1934 to accept this advance as being safe for midwives to supervise after training.

After the advent of the National Health Service in 1948 he resigned his hospital and university appointments and returned to general practice.

He was a firm supporter of the College from its inception and was a member of the Merseyside and North Wales Faculty Board from 1954 until 1961. In 1955 he received the first College Foundation Council Award.

For the last 25 years he devoted himself to general practice which he always regarded as the highest priority in his medical life.

He is survived by a wife, son and three daughters.
