### **APPOINTMENTS**

# NATIONAL ACCESS FOR THE DISABLED WEEK

### QUALIFICATIONS FOR SOCIAL WORK DIRECTORS

Mr Bruce Millan MP, Secretary of State for Scotland, announced that he intends to exercise the powers conferred on him by Section 3 (2) of the Social Work Scotland Act 1968 to prescribe the minimum qualifications required for appointment to a post of Director of Social Work. This will be the Certificate of Qualification in Social Work of the Central Council for Education and Training in Social Work or an equivalent qualification.

### **USE OF CAR BELTS**

It has been estimated that only 30 per cent of occupants of front seats of cars wear seat belts when the car is in motion.

#### **ROAD ACCIDENTS**

The estimated cost of treating victims of road accidents was between £50m and £55m during 1977/78. About 40 per cent of serious injured casualties travelled by car. Victims of road accidents occupied 1.4 per cent of hospital beds.

### **ABORTION IN ITALY**

On 18 May 1978 the Italian parliament approved a Bill legalizing abortion for the first time in the country's history.

The new law permits abortion on demand in the first 90 days of pregnancy for any woman over 18 who

says that childbirth would endanger her physical or mental health. A medical certificate will be required after more than 90 days and girls under the age of 18 must have the approval of a parent or guardian for an abortion.

#### **HOME CONFINEMENT**

A Gallup poll has been reported covering 1,054 people which shows that 82 per cent of women and 75 per cent of men think that facilities for home births should be available. Only 10 per cent of men and 12 per cent of women thought that they should not.

However, in 1974 only 28,425 babies were born at home compared with 689,578 in hospital.

### LONDON TEACHING HOSPITALS

The Government has published a discussion document which proposes that the management of the 12 London postgraduate teaching hospitals should be reorganized.

### GENERAL MEDICAL COUNCIL

The General Medical Council has agreed to proposals to change its rules of procedure for its disciplinary committee. It will in future be possible for any party or witness at disciplinary proceedings to apply for the press and public to be excluded from the hearing. Even if no such application is made the committee may itself exclude the press and public if it thinks that to do so is "in the interests of justice or desirable, having regard to the nature either of the case or of the evidence to be given".

The changes will be discussed with organizations representing medical practitioners and must be approved by the Privy Council before implementation.

# JOINT COMMITTEE ON POSTGRADUATE TRAINING FOR GENERAL PRACTICE

The Joint Committee on Postgraduate Training for General Practice and the Royal College of General Practitioners have approved the vocational training scheme at Newham.

The following vocational training schemes have been re-approved: Hemel Hempstead, Chertsey, Chelmsford, Dewsbury. These schemes are recognized by the Royal College of General Practitioners for the purpose of the MRCGP examination.
