COMMITTEE ON THE REVIEW OF MEDICINES

Professor Owen Wade, MD, FRCPI, FRCPI, is to succeed Sir Eric Scowen as Chairman of the Committee on the Review of Medicines with effect from January 1979.

HEALTH EDUCATION COUNCIL

The annual budget of the Health Education Council was $\pounds 2,097,835$ in the last financial year.

The Council's biggest venture so far was the "Look after Yourself" campaign on which $\pounds 1,400,000$ was spent.

In its recent annual report the Council welcomes the three and a half per cent fall in the number of cigarettes smoked in 1977 compared with the previous year and the "continuing decline in the number of smokers of all ages and both sexes suggesting that the decline of the smoking habit may be accelerating".

CHILDREN'S JOINT COMMITTEE

The membership of the new Children's Joint Committee has been announced under the chairmanship of Professor F. S. W. Brimblecombe, CBE, MD, FRCP, Consultant Paediatrician at the Royal Devon and Exeter Hospital, Exeter and Professor of Child Health in the Postgraduate Medical Institute, Univer-

sity of Exeter.

One third of the members of the new committee are nominated by the Central Health Services Council, one third by the Personal Social Services Council, and the remaining members have been selected by the Secretaries of State.

The establishment of this committee was one of the high priority recommendations of the 1976 Court Report on Child Health Services. This urged an integrated, multi-disciplinary approach to the needs of children and families which should involve specialists in health, education, and social services, as well as parents and voluntary bodies.

COLLEGE OF GENERAL PRACTICE OF RHODESIA

At a meeting of the Medical Council of Rhodesia, held on 25 May 1978, the Council accepted fellowship and membership of this College as an additional registerable qualification.

This registration depends on the fellow or member fulfilling the College Council's postgraduate educational re-

quirements. Should any fellow or member not fulfill the postgraduate educational requirements his or her fellowship or membership of the College will lapse, and the Medical Council of Rhodesia will be notified accordingly, that fellow or member's registration as a fellow or member of the College of General Practice of Rhodesia will be cancelled.

Only in the most exceptional circumstances will the College Council consider reinstating such a fellow or member.

CHILD-RESISTANT CONTAINERS

Since 1 July 1978 it has been unlawful to sell solid-dose, over-the-counter analgesics containing aspirin or paracetamol in containers other than child-resistant containers.

FREE SCHOOL MILK

Mr Denis Healey, Chancellor of the Exchequer, has announced that education authorities would be given discretionary powers to provide school milk for all primary pupils over seven.

HEALTH CENTRES IN SCOTLAND

Mr Harry Ewing, MP, Under Secretary of State at the Scottish Office, recently announced that more than a fifth of the population of Scotland are now served by general practitioners from health centres. Mr Ewing has welcomed the increasing number of hospital consultant services which will be available to general practitioners in new health centres.

KIDNEY PATIENTS RECEIVING DIALYSIS AT HOME

Mr David Ennals, Secretary of State for Social Services, has announced the Government's intention to amend the Social Security Act 1975 to ensure that kidney patients receiving dialysis at home should in general be able to qualify for an attendance allowance.

INSTITUTE OF RELIGION AND MEDICINE

The Institute of Religion and Medicine is offering a £20 prize for an essay of 5,000 words to be submitted by the 31 December 1978. The judges are the Rev. Geoffrey Harding, Professor Eric Wilkes, and Dr David Millard.

REIMBURSEMENT PAYMENTS BY DOCTORS TO SPOUSES

In the Queen's Bench Division the case was heard by Mr Justice Talbot of Dr M. E. Glanvill and his wife Mrs Mary Glanvill of Chard, Somerset, against the Secretary of State and the Somerset Family Practitioner Committee, based on terms of the doctor's contract for services.

The exclusion of salaries paid by a doctor to his wife or other dependents living with him from the NHS scheme, under which doctors are reimbursed 70 per cent of salaries and wages paid to ancillary staff, was held to be unjust and oppressive.
