MRCGP Examinations

The dates for the next MRCGP examinations are as follows:

May/July 1982

Written papers: Tuesday, 11 May 1982. Orals: In Edinburgh during the week ending 26 June and in London during the week ending 3 July 1982. Closing date: Thursday, 11 March 1982.

October/December 1982

Written papers: Tuesday, 26 October 1982.

Orals: In Edinburgh and London during the week ending 11 December 1982. Closing date: 2 September 1982.

The written papers will be held in London, Birmingham, Leeds, Manchester, Exeter, Newcastle, Edinburgh, Aberdeen, Cardiff, Belfast and Dublin. These and other centres may be used as required, subject to a minimum (and in some centres maximum) number of candidates.

advised to apply well in advance of the closing dates. The application fee is as follows:

MEDICAL NEWS

Future of Family Practitioner Committees

Dr Gerard Vaughan, Minister for Health, has announced his decision on the future of the Family Practitioner Committees. He has said that as part of the reorganization of the health service and the setting up of the new district health authorities it is necessary to consider the future of the Family Practitioner Committees should they be independent bodies or should they be part of the new district authorities? He believes that establishing Family Practitioner Committees as health authorities in their own right, with powers to engage their own staff, is most likely both to facilitate the development of primary care services and lead to increased efficiency in the administration of the family practitioner services. When time permits, the Government will legislate to introduce these new arrangements, but this cannot be fitted into the programme for the present session. Interim arrangements will be made since, for the time being, the present statutory position will remain. Dr Vaughan has said that the decision will in no way affect the Government's intention to reduce the proportion of total NHS resources spent on management by 10 per cent by the end of the financial year.

IPPF Budget

The International Planned Parenthood Federation has approved a budget for 1982 of \$50 million. More than \$34 million is to be disbursed in the form of direct grants for family planning activities in 90 countries, almost all in the developing world. The remainder is devoted to international projects.

The Practice Nurse: Training Needs


In 1980 representatives of the British Medical Association, the Council for the Education and Training of Health Visitors, the Panel of Assessors for District Nurse Training, the Royal College of General Practitioners and the Royal College of Nursing set up a Steering Group to examine the training needs of practice nurses and other nurses employed to work in the treatment room of general practice and health centre premises.
